Our goal is to move the Market toward more natural and healthy products. We want to encourage and support producers and vendors who can choose local ingredients, and we prefer organic, when possible. We understand very well that this is not always possible, and will treat each vendor on a case-by case basis. Sustainability also includes the packaging that our vendors and food trucks use. And so, we are encouraging you to use sustainable and recyclable packaging, when possible (which doesn't include Styrofoam or plastic clamshells.)

Montgomery Farmers' Market shall not be responsible for any loss, damage, or injury to any property of Food Truck or any loss, damage or injury to Food Truck or employees of Food Truck, or friends or family, from any cause whatsoever.
